The Steering Committee will manage the process of development and implementation of the Strategic plan.

On September 23, 2010, the Council discussed the purpose of the Strategic Planning Exercise. The Council gave guidance to the Steering Committee on the data to be gathered as part of the Environmental Scan. On March 24, 2011, the Council plans to conduct the Strategic Planning Exercise.

The Council received a report on the proposed amendments to
Registration Regulation that were circulated to the membership and
other stakeholders for consultation following approval at the Council
meeting in June 2010.

The Registrar suggested that the following agenda items be discussed together with the discussion of this agenda item

2010.03.05d: "Mobility" applications from Ontario College members

The Council noted that the response rate to the consultation was very low. Some responses were received from Stakeholder organizations.

The comments from Psychological Associates in Ontario focused on the perceived inequity for current Psychological Associates in Ontario and confusion for consumers accessing psychological services.

These responses addressed the registration regulation amendments that are intended to comply with the mobility amendments to the *Regulated Health Professions Act, 1991* (RHPA) under which a member holding a masters degree and registered in good standing as a Psychologist in another jurisdiction can apply to Ontario and be registered as a Psychologist in Ontario.

As discussed under the report "Mobility Applications", the College has issued Certificates of Registration as a Psychologist to applicants who have a Masters degree and are registered as a Psychologist in another jurisdiction and who have applied for registration in Ontario under "Mobility" provisions. Although the Registration Regulation has not yet been formally amended, the College must comply with the mobility provisions in the *Regulated Health Professions Act, 1991*(RHPA).

Some Psychological Associates currently registered for autonomous practice in Ontario who also hold a registration as Psychologist in another jurisdiction have applied to the College to be issued a Certificate of Registration as a Psychologist.

The Council acknowledged that Psychological Associates in Ontario could seek registration in another jurisdiction that would register them as a Psychologist and then return to Ontario and obtain a Certificate of Registration as a Psychologist. Under "Mobility" provisions, residency is not required to obtain registration in another jurisdiction.

#### The Council identified these important issues:

- Equity issue for Psychological Associate members of the College
- Confusion for the public: The Council discussed the confusion that might result for the public with three categories of members registered with the College: Doctoral level Psychologists, Masters level Psychologists registered under "Mobility" provisions and Masters level Psychological Associates.

It was suggested that one solution may be to issue all Psychological Associates members in Ontario certificates of registration as a "Psychologist".

 Unintended consequences of the AIT: People registered in jurisdictions with less stringent requirements will be able to obtain registration in Ontario. There is a possibility of being required to register less qualified applicants. There was concern that the provisions of the AIT were undermining the authority of regulatory bodies to establish and maintain standards for registration.

 Should the College have new classes of registration for members with non psychology degrees?

The Council reviewed the report from the taskforce on Shaping the Future of Psychology Regulation in Ontario. The taskforce gathered data over the summer and met by teleconference twice prior to this Council meeting.

The Council noted that there was a marked decrease in the number of psychologist members in supervised practice in 2009-2010. It was suggested that data on age range of new applicants may be helpful.

There was also a marked decline in number of Psychological Associate applicants whose highest degree was obtained in Ontario suggesting that there may not be many masters programs in Ontario who provide training to become registered for autonomous practice.

The taskforce will gather data on:

- age range of new applicants
- primary and secondary practice settings for members over the past 10 years.

The Council directed the taskforce to bring recommendations to the Council meeting in December 2010 on the following:

- develop options to address the inequity for current Psychological Associate members
- identify a mechanism to track and report unintended consequences of the mobility legislation, including the potential for registering less qualified individuals
- consider whether the College might register individuals whose training in psychology is narrower than that required for registration as a Psychologist or Psychological Associate, by creating a new class of registrant with a limited scope of practice
- consider whether there will continue to be a critical mass of masters applicants from graduate psychology training

# programs in Ontario and whether masters level registration should be discontinued

The Registration Regulation amendments were to be submitted to Ministry of Health and Long Term Care (MOHLTC) by September 30, 2010. On advice from the MOHLTC, the College will wait until all the Registration Regulation amendments are approved by Council before submitting them. The recommendations on Registration Regulation amendments will be brought to the Council meeting in December 2010, and after approval by Council, the amendments will be circulated to the members and stakeholders for consultation and brought back to the Council meeting in March 2011 before they are submitted to MOHLTC.

The Council suggested that members be made aware that the proposed amendments were required in response to amendments to the *Regulated Health Professions Act, 1991* (RHPA), by including the relevant section of the RHPA in the member communication.

Telepsychology Report

The Council received a copy of the report entitled "Distance Provision of Psychological Services in Canada: Discussion prompts" developed by a working group of the Association of Psychology Regulatory Organizations (ACPRO). In an effort to develop a uniform approach across Canada to regulate provision of this service, the working group made recommendations on cross-jurisdictional practice for the practice of psychology. There was general agreement at the June 2010 meeting of ACPRO that Option 3 or Option 4 of the report be adopted and ACPRO provided the report to all Canadian jurisdictions for their review and feedback.

This report was provided to the plenary session of the Registration Committee July 2010 and to the Executive Committee meeting on October 22, 2010.

Both Committees have reviewed the report and recommend to Council that Option 3: "Registration in home jurisdiction of psychologist and no additional registration required for telepsychology practice in other jurisdictions; psychologist's home jurisdiction responsible for complaints" seems to be the best.

The President welcomed Mr. Vinay Raja, Auditor, Clarke Henning LLP to the Council meeting and invited him to present the Audited Financial Statements for the year ending May 31, 2010 to the Council. Mr. Raja commented that the FAC had reviewed the draft Audited Financial Statements at their meeting on September 16, 2010.

Mr. Raja discussed the following documents that had been provided to Council:

Independence letter Audit Findings Report Draft Financial Statements 2009-2010

Mr. Raja explained that the Independence letter confirms that the College and the Auditing firm are financially independent of each other during the period June 1, 2009 to May 31, 2010 in accordance with the Canadian generally accepted accounting principles. The Auditing Firm has a business relationship with the College and may advise the College on other issues.

The Auditing firm of Clarke Henning LLP also conducted the audit of the Fair Registration practices in the year 2009-2010. Mr. Raja confirmed that this does not constitute a Conflict of Interest as it is not an annual audit.

In the Audit Findings Report, the responsibilities of the auditor, the FAC and the Council are described.

#### **Draft Audited Financial Statements:**

Mr. Raja congratulated the College on a very clean audit and said that the audit went well. There were no unusual transactions and no issues that needed to be discussed with the management. The College is in a very healthy financial position and has a surplus of the end of the financial year 2009-2010. Mr. Raja also provided a one-page summary of the Audited Financial Statements. The College is now required to post the Audited Financial Statements on the College's website and to include them in the Annual report to the Ministry of Health and Long-Term Care.
