#### 2011.04.03 Strategic Issues

.03a Strategic Direction: Update

The President asked the Vice-President to take the Chair and reported that the Strategic Direction Steering Committee met by teleconference on September 14, 2011 to discuss the feedback received in response to the member consultation on the draft Mission and Vision statements. As a result, no change was proposed to the Mission Statement but the Vision Statement ws revised.

#### It was MOVED Mercier

That the Mission and Vision statements be accepted.

The Council agreed that the Mission and Vision Statements be provided in French as well. The President resumed the Chair at the end of this discussion.

#### **2011.04.04 Policy issues**

.04a Report from the Task Force on Shaping the Future of Regulation of Psychology in Ontario

The Council received a report prepared by Mr. Gauthier a member of the Task Force on Shaping the Future of Regulation of Psychology in Ontario respecting the meeting held on September 8, 2011. The Task Force met to review the submissions received by the College in response to the proposed amendments to Registration Regulation which were approved by Council for circulation to Stakeholders at the Council meeting by teleconference on July 6, 2011. Two separate sets of regulation amendments were reviewed and approved for circulation:

- (1) amendments respecting labour mobility, academic and other non-exemptible requirements
- (2) amendments to close the class of masters level Psychological Associate registration and to register current Psychological Associate members as Psychologists,

The full text of the submissions was provided to all Council members in an electronic format.

The report summarized the comments and concerns expressed in the submissions. Many of the comments received were regarding the proposed cessation of Masters level registration.

The Registrar provided to the Council a report on the meeting with the Policy Staff at the Ministry of Health and Long-Term Care. The Ministry Staff expressed the opinion that only the amendments dealing with labour mobility would be given top priority and work on the other amendments that deal with cessation of Masters level registration and registering all Psychological Associates as psychologists would be deferred.

Issues raised in the submissions and discussed at the Council meeting:

Service provided by Masters level practitioners – how is it an issue for public safety

Higher level of training necessary and expected to provide psychological services in the changing world

Is there a higher expectation for services provided by a Psychologist as compared to services provided by a Masters level practitioner

The Task Force gathered data on available terminal Masters programs in Ontario and found that there were very few programs that stop at the masters level and many more that go on to a Ph.D. program. The current MA programs do not deliver all the training needed to provide psychological services and completing such a program does not provide the full training to provide psychological services. While assessment may be included in the Masters level training, diagnosis and intervention are typically deferred to the doctoral level training. In the future, it is possible that there may not be many candidates with masters level training seeking registration with the College.

The Council noted that the Office of the Fairness Commissioner has concerns regarding the closing of a class of registration and may not agree to providing a letter of approval for the proposed amendments to Registration Regulation. It is likely that this issue may resolve itself in the future because of lack of Masters programs that train applicants to provide psychological services. The Council noted that applicants registered in another province may be registered at the College with masters degrees. In addition, HPARB may require the College to register applicants with training in areas other than psychology. There was concern that the standards would become lower.

The Registrar suggested that the Council identify the issues that need to be addressed immediately:

Ministry of Health and Long-Term Care will only process the Mobility amendments at this time

Without a letter of endorsement from the OFC, the Ministry of Health and Long-Term Care will not take forward the proposed amendments to Registration Regulations for approval

HPARB is taking a very broad interpretation of the current Registration Regulations

There are some very glaring weaknesses in the current Registration Regulations

In the Registration Regulation amendments that are provided to Council at this meeting, the Mobility amendments and changes to the academic and other non-exemptible requirements have been separated from other proposed amendments. The Registrar will be meeting with the OFC regarding the letter of endorsement for the proposed amendments.

The above motion was withdrawn in light of the discussion that followed.

Consequences of closing the masters level registration in view of the OFC comments

Important that the College register qualified applicants

The Council discussed the following motion:

That by the time that the grandparenting period ends, the masters degree would cease to be the entry to practice requirement for registration for autonomous practice as a psychologist.

For; 11 Opposed: 1 CARRIED

The Council directed the Task Force on Shaping the Future of Regulation of Psychology in Ontario to prepare language and draft response to the Office of the Fairness Commission on their concerns about closing the masters level registration. The Registrar commented that the OFC is prepared to review another draft of the proposed amendments to Registration regulation and the Ministry of Health and Long-Term Care has advised the College to continue discussions with the OFC.

The Council received the report on the feedback to the proposed "Titles" regulation consultation and noted that all responses were in favour of the proposed amendments.

The College is considering appointing a small task force to start a preliminary discussion. The Vice-President indicated his interest in being a member of the task force.

The President welcomed Mr. Vinay Raja, Auditor, Clarke Henning LLP to the Council meeting and invited him to present the Audited Financial Statements for the year ending May 31, 2011 to the Council. Mr. Raja commented that the FAC had reviewed the draft Audited Financial Statements at their meeting on August 31, 2011.

Mr. Raja discussed the following documents that had been provided to Council:

Independent Auditor's Report Financial Statements for the year ending May 31, 2011

Mr. Raja commented on the new Accounting Standards that are in effect from January 2010. In the Independent Auditor's report, the responsibilities of the Management and the Auditor are described.

The Audited Financial Statements are now dated and signed on the date that Council approves them.

There are new Auditing Standards for not for profit organizations that will be coming into effect on January 2012. The College will not need to adopt International Auditing Standards but can continue to use the Canadian Auditing Standards.

**Draft Audited Financial Statements:** 

Mr. Raja congratulated the College on a clean audit. There were no unusual transactions and no issues that needed to be discussed with the management. The College is in a healthy financial position and has a surplus at the end of the financial year 2010-2011. The College has an Operating Reserve of up to 18 months.

in that seat.

Eligibility to run and serve in District 7, psychological Associates is restricted to members holding a certificate of registration as Psychological Associate. The Registrar suggested that any proposed By-law amendment be deferred until proposed regulatory changes take effect.

In response to a question of whether there would be representation on Council for MA psychologists, the Council directed that the Task Force on Shaping the Future of Psychology Regulation in Ontario consider this issue.
