2015.04.01 Approval of the agenda

2015.04.02 Approval of the Succession Plan

The Council had reviewed the Succession Plan at the Council meeting on June 19, 2015 and suggested some changes which the Succession Planning Committee (President, Vice-President, Dr. Ruth Berman and Public member Mr. Jaffar Hayat and the Acting Registrar) discussed at their meeting on August 5, 2015.

The Succession Planning Committee provided a draft of the revised Succession Plan to Council. The plan was edited, reorganized and reformatted. References to the Director: Investigations and Hearings were replaced by "Alternate Senior Staff". The Auditor was added to the stakeholder communications list and the names of the Associations were spelled out instead of using acronyms.

In the Temporary Short Term Leadership Plan, a change was made to section 4e(iv) regarding Employees in Contract positions. This would allow for the Acting Registrar to renew and extend the contract of an employee that may end during the period of the Temporary Short Term Leadership Plan.

Permanent Leadership Plan:

The Council reviewed the Permanent Leadership Plan which would be put into effect when the Registrar has given a formal notice of retirement or resignation and the role of the Search Committee in the selection of a new Registrar/Executive Director.

The minor wording changes suggested by the Council will be incorporated into the Permanent Leadership Plan.

2015.03.04 Registration Regulation Amendment

The College noticed an error in the recently approved Registration Regulation dealing with the requirements to obtain a Certificate of Registration for a Psychological Associate, authorizing Supervised Practice.

To correct the error, the College needs to submit a very brief amendment to Ontario Regulation 74/15 Registration that was proclaimed on April 7, 2015 to delete the words "one of" from section 23.1. The words "one of" were included in error in the final version submitted to the Ministry.

The Acting Registrar has communicated with Staff at the Ministry of Health and Long-Term Care (MOHLTC) to explain the College's position and requested an exemption to circulate the proposed amendment, since section 23.1 has always required two non-exemptible requirements. The Council received a copy of the letter from the College to the MOHLTC.

If the Minister grants the exemption, the College will submit the proposed Registration Regulation Amendment for approval.

The Council was asked to approve two motions, one to submit the proposed Registration Regulation Amendment and the second to circulate the proposed amendment if the College did not receive the exemption.

In light of the error in *Ontario Regulation 74/15 – Registration* in which the registration requirements to obtain a Certificate of Registration for a Psychological Associate Authorizing Supervised Practice have been unintentionally changed, the College submit an amendment to the Ministry of Health and Long-Term Care regarding *Ontario Regulation 74/15 – Registration* to amend section 23(1) of O.Reg 74/15 by deleting from section 23(1) the words "one of", such that the section that currently reads, in part:

"To qualify for a certificate of registration for a psychological associate authorizing supervised practice, an applicant must comply with one of the following non-exemptible registration requirements:"

Shall now read:

"To qualify for a certificate of registration for a psychological associate authorizing supervised practice, an applicant must comply with the following non-exemptible registration requirements:"
