Message from the President

In 1960, in Ontario, legislation recognizing psychology as a profession was passed and we became regulated under law. Regulation implies that we have a systematic body of knowledge mastered through an extensive program of study and training. It implies that we have a code of ethics and a means of enforcing that code. It means that we are accountable—to each other, and to the public. But most importantly, regulation codifies and exemplifies the social contract that we as practitioners have with the public.

The year 1960 heralded an interesting decade... John Diefenbaker was prime minister of Canada. Teen Angel and three songs by Elvis Presley were in the top ten, Richard Burton and Elizabeth Taylor won best actor and actress at the Oscars. The CBC was not yet broadcasting in color—but it had Mr Rogers, Tommy Ambrose, the Forest Rangers, Festival and Playdate, and of course WO Mitchell's Jake and the Kid.

In 1960, John Kennedy had not been assassinated, Canada was still under the British North America Act, there had been no referendum in Quebec, and the term multiculturalism had not been invented. There was no charter of rights. You could smoke on airplanes—and virtually anywhere else.

Up till 1960, anyone could call themselves a psychologist.

In 1960, psychologists were using the WAIS— and there was no item in the comprehension subtest

about the reasons that people in some professions require a license in order to practice.

Our legislation, regulations and standards have changed a great deal since 1960—and will continue to evolve as our profession grows and changes. In 1960, we worried little about providing services in a multitude of languages, about electronic transmission of files or remote delivery of services. In 1960, psychologists were predominately men, and operant conditioning was a hot new idea.

Many things have changed since 1960. That is as it should be. But the social contract remains.

Congratulations to all psychologists and psychological associates, for 50 years of striving to meet the challenges of providing effective, efficient, creative, safe and relevant services to the public. We ARE the College—and it is our anniversary.

A Brief History

The history of psychology as a regulated profession in Canada began in Ontario with the *Psychologists Registration Act,* 1960, establishing the Ontario Board of Examiners in Psychology (OBEP) and restricting the use of the title "Psychologist", albeit with some exceptions. Québec followed with its own regulatory legislation shortly thereafter.

The members of the Provisional Board of OBEP, Chaired by C. Roger Myers, worked diligently to develop the required foundational documents and OBEP's procedures. regulations were published in the *Ontario Gazette* on October 22, 1960. A doctoral degree primarily psychological in nature and two years of practical experience were required for registration as a psychologist. In addition, for a limited time, applicants with masters degrees and four years of practical experience were also eligible for registration as psychologists.

Board members were formally appointed by Order-in-Council in June 1961, a process that

continued until 1993. Over the years, the Board dealt with registration applications, unauthorized practice and use of title, complaints about members' conduct, professional mobility and relationships with other regulated professions. At least a decade was spent on the Health Professions Legislative Review which culminated in reorganization and consolidation of the regulatory scheme for a number of health professions.

The Regulated Health Professions Act, 1991 and the Psychology Act, 1991 were amended and proclaimed at the end of 1993 together with a set of core regulations. During the intervening two years, the Board served as the Transitional Council for the new College of Psychologists of Ontario and invited the participation of one representative each from the Ontario Psychological Association (OPA) and the Association Ontario οf Counsellors. Consultants, **Psychometrists** and Psychotherapists (OACCPP). The legislation protected a new title of Psychological Associate and the regulations established

the associated registration requirements as a masters degree primarily psychological in nature and four years of acceptable experience plus a period of supervised practice and the same examinations as were required for registration as a Psychologist. For a limited time, applicants deemed to have training equivalent to the masters degree and having five years of experience were eligible to apply for registration as Psychological Associates.

In addition to its role in the registration of new members and regulation of the conduct of members, the College has had the additional role of ensuring that members' knowledge and skills remain current, with a focus on continuing competence and continuing professional development.

In 1961, OBEP was a founding member of the American Association of State Psychology Boards, later to become the Association of State and Provincial Psychology Boards (ASPPB), the alliance of state, provincial, and territorial psychology regulatory agencies

responsible for the licensure and certification throughout the United States and Canada. In addition to creating the Examination for Professional Practice in Psychology (EPPP), ASPPB coordinates cooperative efforts of regulatory boards, facilitates communication among boards, maintains a Disciplinary Data Bank and promotes professional mobility through the establishment of common standards and mechanisms for the recognition of the qualifications of psychologists already licensed in another member jurisdiction. To date, five representatives from Ontario have served on the ASPPB Board of Directors, and each served a year as President of the Association.

OBEP and the College were also involved in the Council of Provincial Associations of Psychologists (CPAP) and the Canadian Register of Health Service Providers in Psychology (CRHSPP) until a few years ago. Currently the College is a member of the Association of Canadian Psychology Regulatory Organizations (ACPRO), the Federation of Health Regulatory Colleges of Ontario (FHRCO) and the Council on Licensure, Enforcement and Regulation (CLEAR). A College representative is currently the Chair of ACPRO and another served as President of the Federation a few years ago.

Legislative change has again been a predominant theme in recent years with several amendments to the Regulated Health Professions Act increasing the number of health regulatory colleges from 21 to 26, enhancing the obligations and accountability of the colleges, focusing on fair registration practices and interprofessional collaboration, and promoting professional mobility through the mutual recognition of the qualifications of individuals legally authorized to practice a profession elsewhere in Canada. In the near future the practice of psychotherapy will be regulated, a change sought by a number of regulated professions as well as several organizations representing unregulated psychotherapists.

Now at the time of the 50th anniversary of psychology regulation in Ontario, the number of registered members has grown from 145 Psychologists at the end of 1961 to almost 2,900 Psychologists and over 500 Psychological Associates at the end of 2009. No doubt the next 50 years will bring further changes to the profession and to professional regulation.

Let us acknowledge the diligence of the Board, Council, staff and registered members in ensuring that the profession is regulated in the service of the public interest.

Dr. Ray Berry, Former Registrar

I wish to send my congratulations to the members of the College on the 50th Anniversary. Sorry I can't make it in person.

It was an honour to serve as Registrar in the early days of the Ontario Board of Examiners in Psychology. Roy Ross, the first Registrar and I were close friends and often talked about the difficulties of starting an important enterprise such as this. It is difficult for Registrars since much of what happens is confidential and Registrars have few people they can talk to. When Roy died Roger Myers was Registrar pro-tem and he asked me if I would accept the Position as Registrar, but because I was serving as Advisor in Psychology in the Ministry of Health I refused. When he came back shortly after and asked me again I said I would write to the Deputy Minister of Health to ask if I could accept the appointment. I was surprised when he agreed but the die was cast and I became the Registrar. I often wondered if the Deputy thought if there was a conflict of interest that I would lean in the direction of the Ministry. On behalf of the Ministry, I often answered my own letters from the Board.

The work of the Board was carried out by an older lady with space in her basement, there were two chairs, a desk and filling cabinets and that was it.

I was concerned about this, we needed an office and a full time person as Registrar. We needed a presence. We had a progressive Board. They agreed and space was found at the Ontario Institute for Studies in Education. Barbara Wand who was a member of the Board courageously agreed to take on the responsibility and I am sure you will agree she did a wonderful job.

Much was happening in the development of our profession. It was an exciting and challenging time.

And here you are celebrating 50 years of progress, but don't worry there are lots of challenges ahead, as Governments try to make changes with Health Care professions. Good Luck.

Greetings from Dr. Barbara Wand Former Registrar

I am delighted to be invited to the 50th anniversary of the regulation of psychology in Ontario. And I am looking forward to meet some new Psychological Associates and Psychologists, and some old friends. But when it was suggested that I might say, or write, at this Anniversary, I had to think. Many psychologists like myself had been practising psychology before 1960. And therefore we had no experience regulation or any examination. And certainly in Ontario, certification in 1960 was done mainly through the Mail. So the Board rarely met the applicant, and only read the applicant's certifications. And as I have also been invited to say something at our 50th Anniversary, I thought that it might be interesting to the younger registrants to hear a bit about the history of regulation itself.

I knew little about about the work of the College until I was a "member" of its antique name called the "Board of Examiners of Psychology" in 1974. Our parttime Registrar, Ray Berry, also had important work with the Ontario Government. We were soon told that the Government wanted him back to work fulltime. He decided to go back, but

fortunately he was able to help us to decide what should be done. If I remember correctly, Ray had useful knowledge about what new legislation that the Government was planning for the health professions. We had many things to consider: insufficient staff, 1200 psychologists already on the Register, and many more coming along.

Over the next few years, the Board and other health professions spent many months going to meetings that were organized by the government where we had lengthy discussions of the draft legislation. "Lengthy" was the word, as meetings possibly went on after I retired in 1991. And it seems that The Psychology Act, 1991 was not Proclaimed until December, 1993.

I also remember another fortunate decision made in the earlier years involving some regulated psychology Boards in the United States and at least one board in Canada - Ontario. In these early years, these Boards got together and decided to organize an Association for regulatory Board members across both countries, so that they could get together and discuss their particular

responsibilities, or problems. No doubt most psychologists and psychological associates are aware of this "Association of State and Provincial Psychology Boards". It seems it was a very wise thing to create, especially because each psychology Board started out in a state, or province. Many boards were finding useful information from the meetings held by ASPPB.



And the College has kept its interest through your own Registrar, Dr. Catherine Yarrow, and other members who have served.





The Ontario College was the first regulatory body for psychology in Canada and has been a leader in the field over the past half century.
