President's Message

Our seasons have changed once again! How did that happen so quickly and without me noticing it? Usually I'm alerted to the changing season by the colder weather and the leaves changing colours, but this year those temperature and colour changes have been slower to occur. In any case, as I write this, it is raining leaves and the lawn is covered with a beautiful red, gold, orange, and yellow blanket!

The College Council participated in a training day on September 29th, prior to the regular September Council meeting. A significant aspect of this day was to begin work to renew the College's Five-Year Strategic Direction as the current one expires this year (2011-2016). In addition, the day provided an opportunity for Council members to discuss and become more familiar with the presentation of the College's quarterly financial materials, to learn more about the process and outcome of policy development, and to further discuss the College's primary duty, to protect the public interest.

At the formal Council meeting held the next day, Council approved the revisions to the *Standards of Professional Conduct* for circulation to the membership for consultation. You will have received a request for your feedback on this critically important document for our profession. Please take the time to review the *Standards* document and provide comment. Your feedback is essential to the Council as it considers the updates to our *Standards*.

Another notable item on the agenda was to receive and discuss your consultation feedback regarding potential transparency initiatives. The response to this consultation was significant – thanks for your thoughtful and reasoned responses! It greatly helps the Council in its deliberations when we have your feedback.

The Council reviewed and approved the Audited Financial Statements for the year ending May 31, 2016, and heard from the auditors that the College is in a financially sound position. As a result, the annual membership renewal fees for the 2017-2018 registration year will remain unchanged. Further discussion resulted in a decision to recommend that the College consult regarding an amendment to *Bylaw 18: Fees*. This amendment would lower fees for examinations and for corporations. You will have received a request to comment on these proposed changes, and I would encourage you to do so. These may also be found on the College website.

Finally, it is with great regret that I inform you that shortly after the September Council meeting, we received the resignation of one of our Public Council Members, Mr. Peter McKegney. Peter's contributions to the College have been significant including serving as Council President last year. In addition, he has been active on the Registration, Executive, and Jurisprudence and Ethics Examination Committees, he chaired the Task Force on Shaping the Future, and has been a regular Public Member observer at the oral examination. Peter demonstrated a passion for the work of the College, and his thoughtful and wise comments during Council and Committee meetings will be missed. We wish him all the best in his future endeavours.

Election to Council 2017

Elections to the College Council will take place in March, 2017 for the three-year term beginning June 2017. Two Council seats are up for election District 4 (East) and District 7 (Psychological Associate). A call for nominations will be distributed to all eligible voters in December.

Electoral District 4 (East) is composed of the counties of Lanark, Renfrew, Leeds and Grenville, Prescott and Russell, Stormont, Dundas and Glengarry, and the City of Ottawa.

Electoral District 7 (Psychological Associates) is composed of the constituency of Psychological Associates who have elected to vote in this District rather than their geographic district

Members wishing to seek nomination are required to have their nomination supported by five nominees who are eligible to vote in the district. The call for nominations, to be distributed shortly, will provide links to further information and nomination forms to be posted on the College website.

Council Highlights – September 30, 2016

Policy Issues

Consultations

Two new consultations were approved for circulation: the proposed revisions to the *Standards of Professional Conduct* and changes to *By-Law 18: Fees*. These have been distributed as well as posted to the College website.

Language Fluency Policy

The Language Fluency Policy was approved and will be incorporated into the College's *Policies and Procedures Manual*. A copy of the policy may be found in the <u>Council Materials</u> in the Resources section of the website.

Examination Accommodations Policy

The Council endorsed the Examination Accommodation Policy which sets out the College's procedures for applicants requiring accommodations in completing the registration process. The policy will be incorporated into the College's *Policies and Procedures Manual* when final formatting has been approved by Council in December 2016.

Strategic Issues

<u>Psychotherapy Clarification Document</u>

The Council approved in principle a document entitled <u>The Controlled Act of Psychotherapy: A Clarification.</u> This was prepared by the Psychotherapy Working Group as requested by the Ministry of Health and Long-Term Care. The Councils of the Colleges of Registered Psychotherapist, Nurses, Social Workers and Social Service Workers, and Occupational Therapists have also given such approval. The Working Group is now considering wider consultation on this document in service of moving toward proclamation of the Controlled Act of Psychotherapy.

Business Issues

Annual Financial Audit

Council received and approved the Annual Financial Statements for the fiscal year ending May 31, 2016.

Other Business

The next meeting of Council will be held on December 2, 2016.

Expert and Mentor Call for Volunteers

The Inquiries, Complaints and Reports Committee ("ICRC") is composed of a mix of practicing psychologists, psychological associates and public members of Council. From time to time, the ICRC requires members of the profession to provide expert opinions in the context of a complaint or report before the ICRC. If a case is referred to the Discipline Committee for a hearing, the expert may be asked to testify about their opinion at the hearing.

ICRC matters that have been dealt with by way of an *Undertaking and Agreement* or a *Specified Continuing Education or Remediation Program* ("SCERP") sometimes include a peer mentorship component as specified by the ICRC. In these cases the Registrar will need to appoint a member of the College to act as a Peer Mentor.

The College would like to establish a roster of members in all areas of practice and in all parts of the Province to call upon should an Expert or Peer Mentor be required. The College is seeking members of the profession who:

- Have worked as an autonomously practicing psychologist or psychological associate in Ontario for a minimum of 5 years;
- Are well versed in the standards of the profession;
- Are not currently serving on the College Council or any College Committee;
- With respect to providing expert opinions, are able to review an ICRC investigation record or Registrar's report, formulate an opinion regarding professional conduct, convey this opinion in writing, and be prepared to testify before the Discipline Committee regarding the opinion should the matter be referred to Discipline;
- With respect to acting as Peer Mentors, are able to assist the member in fulfilling the terms of the *Undertaking and Agreement* or *SCERP*, which may include: meeting with the member on a regular, time-limited basis, reviewing clinical records and/or administrative and office practices, developing and applying an educational module, and reporting on the Peer Mentorship to the Registrar; and
- Undertake to keep confidential all information obtained in the course of acting on behalf of the College.

The College compensates experts for their time at their normal hourly rate, up to the current maximum rate recommended by the OPA. Compensation of Peer Mentors is generally the responsibility of the member, and must be agreed upon by the member and Peer Mentor.

In filling out the <u>survey form</u>, you will be asked to provide your name, contact information, and information about your practice and experience. Should the College contact you to act as an Expert or Peer Mentor, you will also be asked to provide a copy of your current CV.

The College would like to thank, in advance, all those who volunteer to be added to the roster. The College will contact potential Experts and Peer Mentors on an as-needed basis, should their area of practice, client population, experience and geographic location be suitable to the specific case.
