# **President's Message**

This report provides a summary of activities and meetings that I and the Executive have engaged in since the June Council meeting.

The Executive Committee met for two days in August for its regular quarterly meeting and for a day of training. The training day included affirming the College's *Code of Conduct for Council and Committee Members*, as individual members on the Executive, and reviewing the role of the Executive as an orientation for new members. This was followed by participating in a meeting with the Finance and Audit Committee (FAC) and the College Auditors where the year-end audit was presented. The Executive also discussed various aspects of Council governance including the Board Self-Assessment Report with an eye towards how to facilitate discussion of this information at Council. Other discussion focussed on preparing for the September Council meeting.

At the meeting in September, Council considered some policy and strategic issues, the most significant having to do with the use of the title *Psychologist* in Ontario. There is an article in this issue of the *eBulletin* that provides comprehensive information about this Council decision. Other business included a presentation by the College Auditors on the Audited Financial Statements for the College fiscal year ending May 31, 2018. The Auditors were pleased with the results of the audit, and complimentary of the College's financial position and accounting practices. A summary of the Audited Financial Statement is provided in this issue of the *eBulletin*.

At the Council training day in September, the Council participated in learning and discussion involving four different topics. The Council was pleased to have, as a guest speaker, Mr. Thomas Custers, A/Manager, Regulatory Oversight and Performance Unit, Health Workforce Regulatory Oversight Branch Strategic Policy and Planning Division, Ministry of Health and Long-Term Care. Mr. Custers provided an overview of the work of the Ministry and his role as A/Manager of the Regulatory Oversight and Performance Unit. The Council reviewed the report of the Board Self-Assessment completed earlier in the year as well as the results of the Committee Self-Assessment Survey undertaken in the late spring. These reports provided a "bird's eye-view" of the Council and Committee functioning over the past year, which is important for considering aspects of College governance needing to be addressed.

Two other topics were discussed at the training day. The Council received comprehensive information about the various College Committees and their roles and responsibilities. Lastly, Council discussed the recent legislation on the legalization of marijuana and implications this may have for the College and its members.

In mid-October, I was fortunately to have attended the annual conference of the Association of State and Provincial Psychology Boards with Dr. Rick Morris, Registrar & Executive Director and Mr. D'Arcy

Delamere, Public Member and Vice-President of Council. The theme of the conference was, "The Global Practice of Psychology: Impact on Regulation and Credentialing". This included a focus on competency assessment as a recommended method for ensuring public protection given that there are an increasing number of internationally trained psychology practitioners coming to North America from many different educational backgrounds and training experiences.

# Use of the Title Psychologist

#### **Council Decision**

Over the past number of meetings, the Council of the College of Psychologists has been debating academic qualifications for entry to the profession, and the titles available to members. At the meeting on September 21, 2018, these discussions culminated in two decisions. First, the College Council decided to continue to offer registration to individuals with a Masters degree plus four years supervised experience; the current Psychological Associate entry requirement. As well, a motion was passed to pursue granting the title *Psychologist* to all current and future members qualifying for registration as *Psychological Associates*. This change, when it comes into effect, would permit all members of the College access to the title *Psychologist*.

#### Rationale

The purpose and mandate of the College is public protection and to act in the public interest. It is through this lens that the Council viewed this, and all other issues before it. In making this decision, the Council, led by the public members, considered a number of factors, including:

- The misunderstanding among the public of the title *Psychological Associate* as identifying an individual authorized as an independent, autonomous psychological practitioner;
- Recognition that *Psychological Associate* members are not registered solely 'at the Masters level', as is the case in other Canadian jurisdictions which register Masters level providers but rather, the requirement is for a Masters degree plus four years of supervised experience. This is in addition to the year of supervised practice undertaken by all members of the College;
- Members registered with a Masters degree plus 4 years supervised experience have satisfied the College that they are qualified to practice autonomously in their authorized areas of practice;
- These members have met acceptable College academic requirements and, similar to their Doctoral counterparts, have successfully completed one year of supervised practice, the Examination of Professional Practice in Psychology (EPPP), the Jurisprudence and Ethics Examination, and the Oral Examination;
- Members registered with a Masters degree plus 4 years supervised experience have the same scope of practice, as well as the same professional responsibilities and accountability as all other members;
- These members must uphold, and are held to, the same professional standards as all other members;
- Through the required implementation of the Agreement on Internal Trade (AIT), individuals trained at the Masters level and registered in Ontario as well as other Canadian jurisdictions, have been granted the title *Psychologist*;
- As a result of the AIT, Ontario now has three levels of practitioner; Psychologists with a Doctoral degree, Psychologists with a Masters degree, and Psychological Associates with a Masters degree, increasing the lack of clarity among the public.

In considering these factors and in making this decision, the Council was clear not to be suggesting that members with a Masters degree plus 4 years supervised experience have the same or equivalent training to their Doctoral colleagues. Rather, Council recognized the different training and experience received by members, both of which lead to College registration for autonomous practice.

#### **Next Steps**

The College must now undertake to investigate the implications of this change, the steps needed to implement the Council motion, and how the title change can be used to best inform the public about the individual from whom they are receiving psychological services. This will include a wide consultation with numerous stakeholders including: members of the College; members of the public; psychology training programs; professional associations, psychology regulators in other Canadian jurisdictions; other Ontario health regulatory Colleges; as well as discussions with various Ministries including Health and Long-Term Care, Education, and Training, Colleges and Universities as well as the Office of the Ontario Fairness Commissioner.

# Self-Reporting Obligations Under RHPA: What Do I Need to Report?

The Health Professions Procedural Code, being Schedule 2 to the <u>Regulated Health Professions Act</u>, <u>1991</u> requires all regulated health professionals to self-report certain information to their respective Colleges. [s. 85.6.1 - 85.6.4], New mandatory self-reporting requirements, which came into effect on May 1, 2018, expanded previous self-reporting obligations.

#### What do I need to report?

A member must self-report to the College, as soon as reasonably practicable:

- If they have been found guilty of any offence in any jurisdiction;
- If a finding of professional negligence and/or malpractice has been made against them;
- If a finding of professional misconduct or incompetence has been made against them by any body that governs any profession; and,
- If they have been charged with any offence in any jurisdiction. In these instances, any information about conditions of release (bail conditions or restrictions) must also be reported.

Members must also now report if they are a member of any other body that governs a profession, in any jurisdiction, e.g., nursing, law, psychotherapy, etc. All members will be required to report this information in their annual renewal form in the spring of 2019.

#### How do I make a report?

Send an email with the term "self-report" in the subject line to invhear@cpo.on.ca.

The College is developing a self-report form for members to use when making a self-report. When finalized this form can be completed and submitted online. Access to this form will be restricted "for member use only" and will require members to use their membership login information. The College will notify members as soon as the online form is available.

#### What happens after I make a report?

The Registrar reviews self-reports and determines the most appropriate way to proceed, which could include the initiation of an investigation into the information reported. The focus of the review is whether there may be concern abut the member practising safely or if there are steps the College should take to ensure public safety. Further information about investigations is available on the website in the section regarding <u>Professional Conduct & Concerns</u>.

#### Will this information be public?

The College is required to post the following information on the public register:

- Findings of guilt under the <u>Criminal Code (Canada)</u> and/or the <u>Controlled Drugs and Substances Act</u> (Canada);
- Outstanding charges under the Criminal Code (Canada) and/or the Controlled Drugs and Substances
   Act;

- Existing conditions of release following a charge or a finding of guilt under the *Criminal Code* (*Canada*) and/or the *Controlled Drugs and Substances Act*. The College must also post information about any variations to these conditions, if applicable;
- Disciplinary findings and findings of professional misconduct or incompetence by another regulatory licensing authority in any jurisdiction; and,
- Information about a member's license or registration to practice any profession in any jurisdiction.

There are exceptions should a member receive a record suspension from the Parole Board of Canada, a pardon, or if a conviction has been overturned on appeal. For more information, please see the relevant regulation under the RHPA.

#### What happens if I don't make a report?

Failure to report the required information is a serious matter and may result in regulatory consequences, including a referral of allegations of professional misconduct to the College's Discipline Committee.



## **New Complaints and Reports**

Since June 1, 2018, the College received 22 new complaints, opened two new Registrar's Investigation, and 3 new Health Inquiries, for a total of 27 new matters. The nature of service in relation to these matters is as follows:




#### **ICRC Meetings**

The ICRC met on June 12 and August 8, 2018 to consider a total of 13 cases. An ICRC working group also met on August 17, 2018 and considered one case during the course of their work. In addition, 13 teleconferences were held to consider 16 cases.

#### **ICRC Dispositions**


The ICRC disposed of 13 cases during this period, as follows:



\*F&V: Frivolous, vexatious, made in bad faith, moot or otherwise an abuse of process, pursuant to s.26(4) of the Health Professions Procedural Code.

#### **Disposition of Allegations**

Since June 1, 2018, the 13 cases disposed of included the consideration of 41 allegations. The ICRC took some remedial action with respect to 14 (34%) of these allegations.



#### Health Professions Appeal and Review Board ("HPARB")

Since June 1, 2018, one HPARB reviews of an ICRC decision was requested. Four HPARB decisions were received; two confirming the ICRC decisions, and two dismissing the request for review as F&V.
