COVID-19 Vaccine Appointment Information for Members

Dear Members,

You are receiving this email because you either work or live in the catchment area for the Hamilton Public Health Services according to the information you have provided to the College. If this is not the case, please disregard this notice and take steps to correct the information provided.

Hamilton Public Health Services has asked the College to notify members who work or live in their district that you may be eligible to book your COVID-19 vaccine appointment.

Hamilton Public Health Services wishes to communicate the following:

We are pleased to announce that all **Psychologists and Psychological Associates who live and/or work in Hamilton can register for their COVID-19 vaccination** at:

www.hamilton.ca/VaccineRegistration

Once registered, individuals will receive an email from the Ministry of Health inviting them to book a COVID-19 vaccination appointment online based on prioritization outlined in Ontario's [Guidance for Prioritizing Health Care Workers for COVID-19 Vaccination](#), rather than the date you register.

If you previously registered and have not yet received an email from the Ministry of Health, please re-register and include your health card number.

Hospital health care workers or the general public cannot register through this site.

Who is eligible?

All health care workers are eligible to register for a vaccine, in addition to staff working within a health care organization (e.g. physician's office). For the purposes of this vaccine prioritization, 'health care worker' is defined as:

- Anyone working or volunteering in a health care organization (includes regulated health professionals as well as staff not providing direct patient care such as cleaning, food or administration services)
- Any worker providing health care services or direct patient service in a setting outside of a health care organization
