## Bill 171, the *Health System Improvements Act, 2007* Receives Royal Assent

On June 4, 2007, Bill 171, the *Health System Improvements Act, 2007* received Royal Assent. When fully enacted, the legislation will amend several health-related statutes including the *Regulated Health Professions Act, 1991*, particularly *Schedule 2, the Health Professions Procedural Code*. In addition, it will establish four new health regulatory Colleges including a College of Psychotherapists and Registered Mental Health Therapists.

As of early July, the amendments to the various statutes had not been consolidated on the government's e-laws website [www.e-laws.gov.on.ca](http://www.e-laws.gov.on.ca). A copy of the Royal Assent version of Bill 171 may be found at the legislative website [www.ontla.on.ca](http://www.ontla.on.ca) under "Bills & Lawmaking".

### Provisions Currently in Effect

Some of the provisions of Bill 171 went into effect with Royal Assent while others will not go into effect until Proclamation or June 4, 2009, whichever is earlier. This article focuses principally on the amendments to the *Personal Health Information Protection Act, 2004*, the *Regulated Health Professions Act, 1991* and the *Psychology Act*,

1991, which went into effect in June 2007. A brief description of the sections of the new *Psychotherapy Act, 2007* currently in effect is also included.

***Personal Health Information Protection Act, 2004***

The entirety of *Schedule H* of Bill 171, and hence all of the associated amendments to PHIPA, went into effect when the Bill received Royal Assent in June. In general, the amendments clarify the relationship among the *Personal Health Information Protection Act* (PHIPA), the *Freedom of Information and Protection of Privacy Act* (FIPPA) and the *Municipal Freedom of Information and Protection of Privacy Act* (MFIPPA).

***Regulated Health Professions Act, 1991***

While most of the provisions of *Schedule M* of Bill 171 will not go into effect until Proclamation on June 4, 2009, whichever is earlier, amendments to several subsections of the RHPA went into effect when Bill 171 received Royal Assent in June 2007:

- The RHPA now includes a definition of “personal information”,
  - “personal information” means personal information within the meaning of the *Freedom of Information and Protection of Privacy Act*;
- Sections respecting the College’s duty of confidentiality have been amended and provision made for additional exceptions where disclosure of information by the College is permitted. One new exception will permit the College to disclose confidential information when there are reasonable grounds to believe that the disclosure is necessary for the purpose of eliminating or reducing a significant risk of serious bodily harm to a person or a group of persons;
- There are new provisions respecting the collection of personal information by the College, including the collection of information required by the Minister for purposes such as health human resources planning;
- Sections respecting the College’s providing notices or decisions have been amended to allow for delivery of notices or decisions by fax, as well as by mail, and to clarify the presumed date of receipt of such a notice or decision;
- Provisions relating to fines for offences have been revised.

Some of the amendments to *Schedule 2* of the *Health Professions Procedural Code* of the RHPA also went into effect on June 4, 2007:

- The definition of “incapacitated” has been revised to clarify its intent,
  - “incapacitated” means, in relation to a member, that the member is suffering from a physical or mental condition or disorder that makes it desirable in the interest of the public that the member’s practice be subject to terms, conditions or limitations, or that the member no longer be permitted to practice;
- There has been some revision to sections regarding an investigator entering and searching the place of practice (rather than the business premises) of a member;
- There have been revisions to sections relating to fines for making false representations to obtain a certificate and for other offences.

***Psychotherapy Act, 2007***

A few provisions of *Schedule R* of Bill 171 went into effect on June 4, 2007:

- The definitions section identifies the “college” as the College of Psychotherapists and Registered Mental Health Therapists;
- As is the case with the other health profession acts, the *Health Professions Procedural Code*, is deemed to be part of the *Psychotherapy Act, 2007*;



- The Lieutenant-Governor-in-Council is authorized to appoint a transitional Council and a Registrar;
- The Registrar, the transitional Council and its employees and committees are authorized to implement the *Psychotherapy Act*, including processing registration applications and issuing certificates of registration;
- The Minister is authorized to require the transitional Council to make regulations, provide reports or do anything else that the Minister considers necessary to implement the Act.

**Highlights: provisions that go into effect at proclamation or June 4, 2009 whichever is earlier**

Some provisions of Bill 171 will go into effect at Proclamation or June 4, 2009 whichever is earlier. The following are some highlights of these provisions.

***Regulated Health Professions Act, 1991***

- Extensive amendments will be made to the section on the Register. The default will be to make most information about a member available to the public and to specify the limited circumstances under which the Registrar may decline to disclose certain information about a member.
- The investigative powers of the Complaints Committee and the Executive Committee will be merged under a new Inquiries, Complaints and Reports Committee (ICRC) which will also have the authority to require a member to undergo remediation. In addition, there are explicit provisions respecting Alternate Dispute Resolution.
- Minimum requirements for the College's Quality Assurance Program will be specified in the legislation as will the powers of the Quality Assurance Committee.
- Two new mandatory reporting requirements for members will be added. A member will be required to provide a written report to the College if the member has been found guilty of an offence. Similarly, a member will be required to report a finding of professional negligence or malpractice against the member.
- An amended provision respecting funding for therapy or counseling for sexual abuse will permit the funding to be used for therapy or counseling provided at any time after the sexual abuse took place and will not be restricted to treatment received only after a complaint was lodged or a discipline hearing commenced, as is currently the case.

***Psychotherapy Act, 2007***

- The Act will establish the new College of Psychotherapists and Registered Mental Health Therapists of Ontario.
- It will provide for a new controlled act under the RHPA:
  - Treating, by means of psychotherapy technique, delivered through a therapeutic relationship, an individual's serious disorder of thought, cognition, mood, emotional regulation, perception or memory that may seriously impair the individual's judgment, insight, behaviour, communication or social functioning.
- Authorized to perform this new controlled act will be members of the new College of Psychotherapists and Registered Mental Health Therapists, members of the College of Psychologists, the College of Physicians and Surgeons, the College of Nurses, the College of Occupational Therapists and the Ontario College of Social Workers and Social Service Workers.
- Although several professions will be authorized to perform the new controlled act, no person other than a member of the College of Psychotherapists and Registered Mental Health Therapists of Ontario will be permitted to use the title "psychotherapist" or "registered mental health therapist", a variation, an abbreviation or an equivalent in another language.

As additional information and implementation plans become available, the College will provide further updates to members.

To this end, a supervision working group has been established and will soon commence its work. *Bill 171: The Health System Improvements Act* received Royal Assent on June 4, 2007. The legislation, when fully enacted, will make extensive amendments to the *Regulated Health Professions Act* and the *Psychology Act* and will create the new College of Psychotherapists and Registered Mental Health Therapists. Our College will be available to lend knowledge and experience to help in the establishment of the new College while working to ensure that our members continue to provide high quality psychotherapy services.

Over the past year, the College conducted a comprehensive review of the By-laws and Policies, work that will continue in the coming year. In addition, the past year saw the completion and launch of the new and improved College website.

On a personal note, this is my fifth year on Council and I have been entrusted with a role, which no doubt, will be a challenge to fill. Nonetheless, I look forward to this challenge and to promoting the objects and mission of the College. As a self regulating profession, the College's role is to serve the public interest by insuring that psychological services in Ontario are effective, safe and accessible. I have always believed that this mandate of the College is one that is supported by the members of our profession. It is my hope that we will continue to work with College members and the associations in a way that serves the public and enhances the practice of the profession.

The Health Professions Procedural Code (Code) of the Regulated Health Professions Act, 1991 requires the Registrar to maintain a register of member information (23.1). This section of the Code prescribes the minimum information required to be maintained for both individual members and professional corporations, the information that must be available to the public, and the access to information provisions. In addition, the Code permits the College to prescribe other information to be maintained and made public. In December 2003, the College Council, following consultation with the membership, approved *By-Law 25: The Register and Related Matters* respecting additional information to be maintained on the register.

## Consultation on Amendments to *By-Law 25: The Register and Related Matters*

At the Council meetings of March and June 2007, amendments to By-law 25 were reviewed and approved for circulation to the membership as per the Code, which requires proposed changes to this by-law be circulated to the membership at least 60 days before it is approved for implementation.

The following amendments were approved for circulation and comment:

1. In response to frequent requests from consumers, third party payers, other members as well as those wishing to make a referral, it was recommended that information about a member's *area(s) of practice* and *client groups served* normally be available to the public. Currently, this information is contained on the register but is only made public upon request of the member. The proposed amendment would remove "8. The member's Area(s) of Practice and Client Groups Served;" from the list of information excluded from the public portion of the register. The change however, would not include the areas of practice and client populations served for members holding Certificates of Registration for Supervised Practice as these members have not yet demonstrated competence in their area(s) of practice.
2. Since supervised practice members' work is supervised by an autonomous practice member and clients are to be informed of this arrangement, the proposed amendment would record the names of the supervisors on the register and permit this to be available to the public.
3. The Standards of Professional Conduct [s.9.8.1(2)] require that, "A member in private practice shall make arrangements, preferably with another member, for the security and maintenance of private practice client records in the event of the member's incapacity or death. The member shall inform the College of these arrangements". The change to the by-law would permit the name and contact information of the individual who has agreed to take responsibility for a member's files to be recorded on the register and for this to be available to the public in the event of his/her incapacity or death.
4. As a housecleaning item, Section 4, which describes the register information that is available to the public, has been revised to note the items excluded from the public register, rather than those included, as there are far fewer exclusions.

## BY-LAW 25: THE REGISTER AND RELATED MATTERS

*[Approved by Council December 2003]*

This By-law is made under the authority of the Regulated Health Professions Act, 1991 as amended 1993, 1996, 1998, 2000 and 2001, subsections 94(1) (1.1, 1.2, 1.3) and the Psychology Act, 1991 as amended 1998.

1. (1) A member's name in the register shall be the member's name as provided in the documentary evidence used to support the member's initial registration and shall be consistent with the name used by the member on his or her diploma or degree in psychology.
  - (2) The Registrar shall direct that a name other than as provided in subsection (1) be entered in the register if such a request is made by the member and the Registrar is satisfied that the member has validly changed his or her name and that the use of the name is not for an improper purpose.
2. (1) Unless otherwise approved by the Registrar, a member's business address in the register shall be the address of the location in Ontario where the member principally engages in psychological practice or, if the member does not practise in Ontario, the member's address, as designated by the member.
  - (2) A member's business telephone number in the register shall be the telephone number of the location in Ontario where the member principally engages in psychological practice or, if the member does not practise in Ontario, the telephone number of the location designated in subsection (1).
3. In addition to the information required under subsection 23(2) of the Health Professions Procedural Code of the Regulated Health Professions Act, 1991, the register of the College shall contain the following information with respect to each member:
  1. The member's name and any changes to the member's name which have been made in the register since he or she first became registered with the College;
  2. The member's registration number;
  3. The date when the member's certificate of registration was first issued by the College;
  4. If the person ceased to be a member as a result of his or her resignation or death, the date upon which the person ceased to be a member;
  5. The highest degree in psychology held by the member and on which registration is based;
  6. The name of the educational institution from which the member received his or her highest degree in psychology upon which registration was based, and the year in which the degree was obtained;
  7. The classes of certificates of registration held by the member, the date on which each was issued and, if applicable, the termination or expiration date of each;
  8. The member's Area(s) of Practice and Client Groups Served;



9. The address and telephone number of the location in Ontario where the member principally engages in psychological practice;
10. The member's home address and home telephone number;
11. The member's preferred address for communication by the College;
12. If the member is a shareholder, officer or director of a health profession corporation which holds a certificate of authorization issued by the College, the name of the health profession corporation and what position or title, if any, the member holds with that corporation;
13. Any term, condition or limitation on the member's certificate of registration;
14. The results of any disciplinary or incapacity proceeding in which a member's certificate of registration was revoked and the date of the revocation;
15. If the member's certificate of registration is subject to an interim order of the Executive Committee, a notation of that fact, the nature of that order and its effective date;
16. If the member's certificate of registration is suspended for non-payment of the annual fee or any fee required by the College, a notation of that fact and the date upon which the suspension took effect;
17. If the member's certificate of registration is suspended for failure to comply with the order of a Board of Inquiry, a notation of that fact and the date upon which the suspension took effect;
18. If an allegation of professional misconduct or incompetence has been referred to the Discipline Committee in respect of the member and is outstanding,
  - (a) a notation of that fact and whether the allegations are for professional misconduct or incompetence,
  - (b) a brief summary of each specified allegation, and
  - (c) the date of the hearing if the hearing date has been set or the next scheduled date for the continuation of the hearing if the hearing has commenced;
19. If the question of the member's capacity has been referred to the Fitness to Practice Committee and not yet decided, a notation of that fact;
20. If the person ceased to be a member as a result of his or her resignation after a referral to the Discipline Committee, a brief summary of the allegations against the member, and the fact that the resignation occurred in the face of such allegations, or such other notations as may be agreed to by the member and the Registrar;
21. If, prior to January 1, 1994, the person ceased to be a member as a result of his or her resignation after a referral to Discipline, a brief summary of the allegations against the member, and the fact that the resignation occurred in the face of such allegations, or such other notations as may be agreed to by the member and the Registrar;



22. If the member has been required to attend before the Complaints Committee to be cautioned, a notation of that fact;
23. If a finding of professional misconduct, incompetence or incapacity has been made against a member by any other regulatory body, in or outside of Ontario, or in any other health profession,
  - (a) a notation of that fact,
  - (b) the date of the finding and the name of the governing body that made the finding,
  - (c) a brief summary of the facts on which the finding was based,
  - (d) the penalty, if any, and
  - (e) where the finding is under appeal, a notation of that fact, which notation shall be removed once the appeal is finally disposed of;
24. If a decision of the Discipline Committee has been published by the College with the member's name included,
  - (a) a notation of that fact, and
  - (b) identification of the specific publication of the College containing that information;
25. In the case of a member holding a Certificate of Registration Authorizing Supervised Practice, the names of the member's supervisors;
26. In the event of a member's incapacity or death, the name(s) and contact information of the individual(s) who will have custody of the member's client records.
- 3.1 Notwithstanding the provisions of section 3, the College shall delete from the register any information that would otherwise have been required to be maintained under this by-law in respect of any member who died which is no longer needed in order to protect the public.
- 3.2 In addition to the information under subsection 23(2) of the Health Professions Procedural Code of the Regulated Health Professions Act, 1991, the register shall contain, in respect of each health profession corporation to which a certificate of authorization has been issued by the College, the following information:
  1. The certificate of authorization number;
  2. The head office and mailing address of the health profession corporation;
  3. The date upon which the certificate of authorization was first issued;
  4. If the certificate of authorization has been revoked, a notation of the fact, the date when the revocation occurred and a brief summary of the reasons for the revocation;
  5. If the certificate of authorization was revised or a new certificate of authorization was issued to the health profession corporation, a notation of that fact and the date when that occurred;
  6. The name, as set out in the College register, of each of the officer and director of the health profession corporation and the title or office held by each;
  7. The practice name(s) or business name(s), if any, used by the health profession corporation;
  8. The address and telephone number of each location at which the health profession corporation carries on business;



9. A brief description of the business activities carried on by the health profession corporation.
4. Subject to section 4.1, ~~the all~~ information contained in section 3, excluding information in paragraphs 2, 10, 11, 22, 23; and all information in section 3.2 1, 3, 4, 5, 6, 7, 9, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 24, and, at the member's request 8 of section 3 and paragraphs 1, 2, 3, 4, 5, 6, 7, 8, and 9 of section 3.2 shall be information available to the public from the register of the College under paragraph 4 of subsection 23(3) of the Health Professions Procedural Code of the Regulated Health Professions Act, 1991.
- a) At the discretion of the Registrar, information designated as public in the register may be provided to any person in printed, electronic or oral form.
  - b) The College will not provide a member's registration number but may verify the number upon request.
  - c) In the case of a member holding a Certificate of Registration Authorizing Supervised Practice, information respecting Area(s) of Practice and Client Groups Served will not be made available to the public.
- 4.1 At the discretion of the Registrar, a member's previous name or names shall not be information available to the public from the register of the College under paragraph 4 of subsection 23(3) of the Health Professions Procedural Code of the Regulated Health Professions Act, 1991.
- 4.2 Information which, but for the commencement of an appeal or other legal proceeding, would have been available to the public from the register of the College under paragraph 4 of subsection 23(3) of the Health Professions Procedural Code of the Regulated Health Professions Act, 1991, shall be available to the public from the register of the College as if no appeal or legal proceeding had been commenced.
5. (1) A member shall immediately provide to the College, if requested to do so by the Registrar, the following:
- a) His or her home address and home telephone number;
  - b) The address and telephone number of,
    - (i) the location in Ontario where the member principally engages in psychological practice, and
    - (ii) all other locations, whether inside or outside of Ontario, at which the member engages in psychological practice;
  - c) The member's business address and business telephone number,
  - d) The member's preferred address for communication by the College;
  - e) A description of the services which the member provides in each of his or her practice locations.
- (2) If there has been any change in the information which is required to be provided under subsection (1) the member shall notify the Registrar in writing of the change within thirty (30) days of the effective date of the change.

In an effort to introduce the members of Council, reproduced below are the Biographical and Candidate Statements they submitted as part of the election/appointment process.

### **Milan Pomichalek, Ph.D., C.Psych.** **Electoral District 1 – North**

#### **Biography and Candidate Statement.**

I am currently working as a Clinical and Forensic/Correctional Psychologist on staff at the Northeast Mental Health Centre (North Bay Campus). I am the sole psychologist in the Centre's Forensic Program (a 28 bed medium security unit and a 24 bed minimum security unit). In addition to my primary clinical duties I also provide supervision to both undergraduate and graduate interns, and serve as the Chair of the Centre's Research Ethics Board. I have also served as an expert witness in court.

I received my Ph.D. in Clinical Psychology from York University in 2001, and prior to accepting my present position I worked in the private sector, mostly with motor vehicle accident victims. I am at present in the process of developing a limited private practice focused on that area of expertise. I am a member in good standing with the APA, CPA, and the Society for Personality Assessment, and I am registered with the Psychologists Board of New Zealand.

I believe that the general public, and even other professionals, hold many misconceptions about the role of psychologists. Providing education about our unique contribution to mental health care is important not only for us as professionals, but also helps to protect the public. One way to accomplish this, and to increase our visibility, is to advocate for increased access to our services, especially in underserved Northern regions of the province.

With a view to this goal it is important, in this time of dwindling educational and internship opportunities, to ensure that individuals aspiring to join the profession are not prevented or discouraged from fulfilling the registration requirements by their geographical isolation. I believe that it is incumbent upon the College to seek to develop guidelines and parameters for using new technologies such as videoconferencing to this end, if such can be employed without sacrificing the rigorous standards of our profession.



I also feel that many of us practicing in the North sometimes feel too geographically removed from our southern Ontario counterparts to have our voices heard. If elected, I promise to make myself accessible to all District 1 – North members as their representative at Council, and to commit myself to raising issues and challenges specific to the practice of psychology in our part of Ontario.

**Mustaq Khan, Ph. D., C. Psych.**  
**Electoral District 2 - Southwest**

**Biography and Candidate Statement.**

Mustaq Khan, Ph. D., C. Psych. attended the University of Toronto, University of Western Ontario, and University of Windsor. He has been a Member of the College since 2001 and a member of the College's Fitness to Practice Committee since 2005. His main clinical role is as staff psychologist on the Mood Disorders Program at Regional Mental Health Care—London, where he assesses and treats complex mood disorders. He is also an associate with a private practice, and a consulting psychologist for the Salvation Army's youth custody center. **Biography and Candidate Statement.**

My career in psychology has spanned more decades than I care to think about, but during that time I have managed to have a taste of a variety of different areas of psychological practice. I am currently the neuropsychology consultant for Ontario for Correctional Services Canada. This position came on the heels of 25 years in a variety of positions at a provincial psychiatric hospital—general adult psychiatry, geriatrics, forensics—as well as stints as a department head and a program director. I have practiced at both the masters and the PhD level and have a good appreciation of the complexity of the issues around the registration and “name” issues. In addition, I have a long standing but small private practice, I have taught at both university and community college level, I write newspaper and magazine columns about psychology I am actively involved in graduate student training, am a member of a number of professional organizations (including the Canadian Association of Chiefs of Police—I suspect the only Psychologist member!), have degrees from McGill, Purdue and Queen's...

I guess the point is that I have a fairly broad perspective on the practice of psychology and I think that is probably the strength I bring to the College. I am currently running for my third and therefore last term on Council, and it is work I consider valuable and essential to the well-being of our profession. My role on Council is that of “worker bee.” I don't have a “cause” within the profession, although I have been very involved with the Complaints Committee over the past few years and hope to be able to continue work in this area, as the College grapples with implementing the many significant changes to this process that the government has proposed in the past year. I think my contribution is to offer the perspective of those of us out in the trenches, to try to maintain that ever delicate balance between the protection of the public and the interest of the profession (which are, in the end, the interests of the public). or even to stop doing what they are doing. But equally it means assisting the profession as whole to offer all the many things it has to offer.

**Mary Ann Evans, Ph.D., C.Psych.**  
**Electoral District 8 – Academic**

**Biography and Candidate Statement.**

I grew up in Kirkland Lake, a small and snowy but nurturing Northern Ontario gold-mining town, blissfully naive to the concept of social class until Sociology 100 in my first year at university. I completed my B.A. at the University of Toronto in 1972 and my Ph.D. at the University of Waterloo in 1980, and was subsequently registered as a psychologist in the province of Ontario. In 1981 I joined the faculty of the University of Guelph where I am a professor of Psychology and Director of Clinical Training in its graduate program in Clinical Psychology: Applied Developmental Emphasis, a programme accredited with the Canadian Psychological Association. My teaching includes graduate courses on cognitive assessment and learning disabilities, supervision of clinical practica, and undergraduate courses in communication development, psychology and education, and learning disabilities.

Some of my administrative work has included being Co-Director of the University's Learning Opportunities Program from 1998 to 2001, a program for supported integration of students with learning disabilities. Here I developed a course on learning disabilities specifically for students with learning disabilities which continues at the University of Guelph to this day. From 1991 to 1994 I was a scientist/practitioner representative on the Board of Directors of the Canadian Psychological Association, and from 2004 to 2007 have been a member-at-large on the executive of the Canadian Council of Professional Psychology Programmes.

My research, funded by the Canadian Language and Literacy Research Network and Social Sciences and Humanities Research Council of Canada, has focused primarily on communication development, on the social and cognitive aspects of shyness in children, on shared book reading, on home literacy experiences children have that may foster beginning reading skill, and on young children's print specific knowledge. I have supervised 38 theses at the graduate level. I am a fellow of the Canadian Psychological Association, have received the Award of Excellence in Teaching twice from the Department of Psychology, and in 2005 received a Distinguished Faculty Award from the University of Guelph.

With my husband John Ayre, I have three children, and would have loved to have more but for a very busy career. Recently, I gained one more in my new role as grandmother.

## The College Council

The Council of the College is composed of elected and appointed individuals. The current Council has six members elected geographically from among the members of the College, one member elected from among the psychological associate membership, two members appointed representing training programs in psychology, six appointed members of the public, and one ex-officio psychological associate seat. ### **Electoral District 1 (North)**

**Milan Pomichalek, Ph.D., C.Psych.** received his psychology training at the University of British Columbia and York University. ### **Electoral District 3 (Central)**

**Dorothy Cotton, Ph.D., C.Psych.** obtained degrees from McGill, Purdue and Queen's, and became registered as a psychologist in 1986, after several years as a psychometrist. Her background is as a generalist in the area of clinical psychology and her clinical career has included periods in child psychiatry, general adult psychiatry, geriatrics, and forensics. She was formerly the Chief Psychologist and Administrative Director of the Forensic Service at a provincial psychiatric hospital. Currently, Dr. Cotton is currently a psychologist with Correctional Service Canada, where she provides neuropsychological services. Dr. Cotton has taught at both the graduate and undergraduate levels in the Department of Psychology at Queen's, and lectured in the Department of Psychiatry. She is co-chair of a national police/mental health systems liaison committee and holds a diplomate in police psychology. She has a small private practice and writes regularly about psychological topics for a variety of magazines, has written a book on stress management and regularly presents to professional and community groups. She has been on the board of OPA as well as OACCPP and has served on boards for a variety of community agencies and groups. Dr. Cotton is on the Executive Committee of the Council, is currently Chair of the Complaints Committees and also serves on the Discipline Committee. Dr. Cotton is in her third term on the College Council which continues until 2010.



**Electoral District: No. 4 (East)**

**Clarissa Bush, Ph.D., C.Psych.** has practiced primarily in the area of neuropsychology at two Ottawa since obtaining her Ph.D. from McGill in 1984. She has worked on various inpatient rehabilitation teams, in an outpatient memory disorder clinic and is presently in private practice as well as holding a part-time position at the Children's Hospital of Eastern Ontario. Dr. Bush has a diplomate from The American Board of Professional Neuropsychology. She has always had a strong interest in clinical teaching and from 1999 to 2006 was the training director for a CPA accredited internship in clinical neuropsychology. Dr. Bush was a member of the first group to train to perform capacity assessments when the Substitute Decisions Act was proclaimed in 1995. **Electoral District 5 (GTA East)**

**Janice L. Currie, Ph.D., C. Psych.** received her psychology training at the University of Toronto and the University of Waterloo obtaining her Ph.D. in 1981. Upon graduation, she held a postdoctoral fellowship for one year within the Neurology Department at the Hospital for Sick Children, working on the Learning Disabilities Research Project. Dr. Currie joined Psychological Services at the Scarborough Board of Education working as a psychologist and later, as Senior Psychologist. In 1996, she became Chief Psychologist with the Board of Education for the City of York. Currently, she is the Senior Manager of Professional Support Services for the amalgamated Toronto District School Board. In this position, she supervises Psychological, Social Work & Attendance, Occupational/Physiotherapy and Speech-Language Pathology Services for the Board. Dr. Currie has been a member of APA, CPA and OPA and served as the Ontario Psychological Association's representative to the Minister's Advisory Council on Special Education (MACSE). Dr. Currie was recently elected as Vice-President of the College Council, is Chair of the Discipline Committee and also serves on the College's Fitness to Practice Committee. Her term on Council continues to 2009.

**Electoral District 6 (GTA West)**

**Dalia Slonim, Psy.D., C.Psych.** received her doctorate from The Chicago School of Professional Psychology in 1988, and trained as a developmental neuropsychologist at the University of Chicago Hospital, Billings Memorial. She became registered as a psychologist in Ontario in 1989, and also holds licenses as a clinical psychologist in the states of Illinois and New York since 1996 and 1999, respectively. Dr. Slonim has worked as a psychologist practicing Clinical Neuropsychology and Clinical Psychology at both the Wellesley Hospital and St. Michael's Hospital and as a consultant to Surrey Place Centre. She is presently at Bloorview Kids Rehab and in private practice. Dr. Slonim was elected to the College Council in 2003 and was recently elected as President of the College. Her term continues to 2009.

**Electoral District 7 (Psychological Associate)**

**Mr. Glenn Webster, M.Ed., C.Psych.Assoc.** received his honours B.A. in psychology from Nottingham University G.B. in 1968. After teaching 3 years in England, he moved to Jamaica and then to Manitoba. He moved to Toronto and OISE/UT to obtain an M.Ed. Two further years of graduate study have not yet produced a doctorate. Mr. Webster has worked at the Toronto Catholic District School Board psychology department for 32 years, maintains a private practice and has taught community college, and university psychology courses.
